Information that we collect from you:

You may browse our website and read our social media pages without providing any personal information whatsoever.

We only collect personal information from you if you voluntarily submit such information to us and we limit the amount of information we collect to only that required to provide your wedding. When you book a wedding with Bride Beautiful we ask that you provide your name and correspondence address, email address and telephone number.

We may also collect information from messages you post to our social media pages and emails that you send to us, or from forms completed by yourself at our Open Days.

Use of your information:

Your information will enable us to provide you to supply the wedding services you have requested. It will enable you to participate in interactive features of our website, when you choose to do so. It will also enable us to invoice you and to contact you concerning your wedding.

We will also use and analyse the information we collect so that we can administer, support, improve and develop our business.

In particular, we may use your information to contact you for your views on our services and to notify you occasionally about important changes or developments to the website or our services.

Further, where you have consented, we might also use your information to let you know by email about Open Events and additional services (e.g. the addition of extra services such as wedding stationery) which we offer which may be of interest to you. If you change your mind about being contacted in the future, please let us know.

Disclosure of your information:

We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law.

Security and data retention:

We employ security measures to protect, so far as reasonably possible, your information from access by unauthorised persons and against unlawful processing, accidental loss, destruction and damage. We will retain your information for a reasonable period or as long as the law requires or permits.

The couples section on our website has been built as a membership system so the pages are fully protected and are secured with a personalised login facility, randomly generated & provided only to yourselves.

Our Cookie Policy:

Cookies are small amounts of information which we may store on your computer. Unless you have indicated your objection when disclosing your details to us, our system will issue cookies to your computer when you log on to the site.
